In most EU Member States, foreign qualifications, especially if earned in third countries, are largely discounted in the labour market.

The Europe 2020 strategy has identified the improvement of the labour market outcomes of immigrants as a key step for meeting the target of a 75 per cent employment rate in the EU by 2020. The key for achieving this is the proper assessment and certification of migrants' qualifications and skills.

LikeHome will:

- ▼ **Develop recognition process** in labour market in order to overcome the obstacles to find an adequate employment.
- ▼ **Make available tools** to prove migrants' ability to use their competencies in the labour market.
- ▼ **Create an e-tool** for migrants and refugees that assess basic computer knowledge, the use of smartphones and the ability to switch between languages.
- ▼ **Implement language courses** to help them to integrate labour market as well as courses about the host country legislation, obligations and rights.

- ▼ **Establish agreements** between agencies and institutions.
- ▼ **Create an information platform** for dissemination.

- ▼ **Simplification of the recognition process** of prior learning, competencies and qualifications of migrants.
- ▼ **Creation of new tools and several methods** for pre-migration screening in order to help you to assess and recognise any kind of qualifications, competencies and experience.
- ▼ **Providing** with training material.
- ▼ **Setting up a legal framework** for migrants that don't have proof of their qualifications.
- ▼ **Development of tools** in order that you can know the institutions of the country of origin and their level of education.
- ▼ **Establishment of links** to local university degrees and with consulates.
- ▼ **Setting up links** between the country of origin and the host country to overcome administrative obstacles and constitution of a table of correspondence of qualifications.
- ▼ **Development** of a country education profiles database.
- ▼ **Creation of a standard** of certification systems in EU countries.
